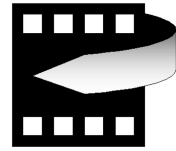


End Credits Film Club



WELCOME TO 2023

END CREDITS' 25th YEAR.

Yep, 25 years of operation. We're still here homeless but alive and that, (life - not the homelessness) is thanks to not only the volunteers who give their time to keep the club running but most importantly to all of you who attend our screenings and buy tickets to do so. We couldn't be here without you.

As has happened on many occasions in the past our cinema program has needed to change venues and this year the regular program of current theatrical release screenings will be held on Unseen Cinema Sundays at Event Cinema Cairns Central most often in the usual 4:30pm time slot. Please check our website <http://endcredits.org.au> for all screening time details and for ticket sales.

Due to a 30% rise in the cost of cinema hire it has become necessary to add \$2.00 to our ticket prices. Casual Adult tickets will be \$22 and Film Club Members \$17. We will only have access to one of the smaller capacity auditoriums at Events Central, so we encourage you to buy your tickets in advance and arrive early enough to ensure you can select your preferred seat location in the theatre. Unsold seats will be available for purchase (cash or card) from our table in the foyer 60mins before the film's start time.

This past year End Credits was included on the Register of Cultural Organisations and became a registered charity with Tax Deductible Gift Status. All steps we believe may contribute one day to End Credits ending its status as the oldest, homeless, not for profit association in Cairns.

Our most pressing need is to find an economical, large, centrally located, equipment storage solution and operations base for our collection of screening, sound, and other film and projection equipment. A place ideally suited to also hosting smaller screening events which are often requested but not economically viable to hold at commercial theatres.

Our theatrical cinema program is just one aspect of the club's activities which also include our Starry Night Outdoor Cinema fundraising program, small venue pop-up screenings, contracted outdoor movie nights, and SCREENSCAPE, a project funded filmmaker development, training, and mentoring program.
